6. Special Presentation: Mansfield UMADAOP

Carol Payton and Dennis Baker presented great and positive information and news regarding the growth and success of UMADAOP. They now have 4 locations in Mansfield, and numerous programs which include treatment services, intensive outpatient therapy, aftercare and relapse prevention. Opiate and Medication Assisted Treatment. With an 88 to 90% success rate. Many other programs including Circle for Recovery, Family Re-Entry, Help Me Grow, Sober Living Recovery house's, Driver Intervention program, Drug Court treatment and Assessments. Plus, the Community Outreach Center on Trimble, working with our youth. They have many programs to provide early intervention and prevention while they supply a safe, fun learning environment. There is no charge to anyone, this is all done thru donations and funding events. Over 400 children a year benefit. They also have just purchased there first bus. Children are 8 to 14 years of age, from all around the surrounding area.
