The Executive Director for the Mental Health & Recovery Services Board (MHRSB) of Richland County, Jim Kinnan, resigned his position after four years of service to individuals and families dealing with Behavioral Health issues.

During Kinnan's tenure at the MHRSB positive changes occurred:

- \$948,000 in revenue gained from grants
- In 2006 passed a one mill renewal levy
- Implementation of the Network of Care Web Site which provides information regarding behavioral health services, laws, and related news
- Built collaboration including Early Childhood Mental Health, Positive Parenting Program, and the Suicide Prevention Coalition
- Received a community Partnership Award and Project Collaboration Award from the Area Agency on Aging




Jo Ann Keller Administrative Assistant


Fiscal Year 2007 Revenue \$12,158,313



The Mental Health & Recovery Services Board received dollars from five major sources in State Fiscal Year 2007.

- \$1,628,969 generated from a 1-mill levy, which was passed in 1997 and renewed in 2006. This levy will expire in 2011.
- \$1,187,622 generated from The Ohio Department of Alcohol & Drug Addiction Services through Federal programs.
- \$729,950 generated from The Ohio Department of Alcohol & Drug Addiction Services through State programs.
- \$2,908,267 generated from The Ohio Department of Mental Health through Federal programs.
- \$5,503,065 generated from The Ohio Department of Mental Health through State programs.

Fiscal Year 2007 Expenditures \$12,034,171



The Mental Health & Recovery Services Board paid three main types of expenditures in State Fiscal Year 2007.

- \$9,369,764 paid to providers for Mental Health treatment and prevention services.
- \$2,044,255 paid to providers for Alcohol & Drug Addiction treatment and prevention services.
- \$620,152 paid for Board administration.
