#### <u>Cash Position</u> – Carolyn Muth

The cash beginning balance as of September 30, 2011 was \$5,727,712.12. Total revenue for October was \$832,236.69. Expenditures for the same period were \$872,979.17, leaving an ending balance on October 31, 2011 of \$5,686,969.64. This is a decrease of \$40,742.48.

Dave Krenrick asked if Board members would be receiving Rolling Allocation reports. Tom Chambers said they should be available to the providers by next week. Since the Board does not meet in December, it will be January before they are distributed to Board members.

### \* Finance Committee Report – Lanette Remaley

Lanette reported the Finance Committee met November 8<sup>th</sup>. They reviewed the UMADAOP audit for Fiscal Year 2009. This audit generated some discussion as several items were unclear.

The CACY audit for Calendar Year 2010 was delivered just prior to the Finance Committee meeting, and it was also discussed.
