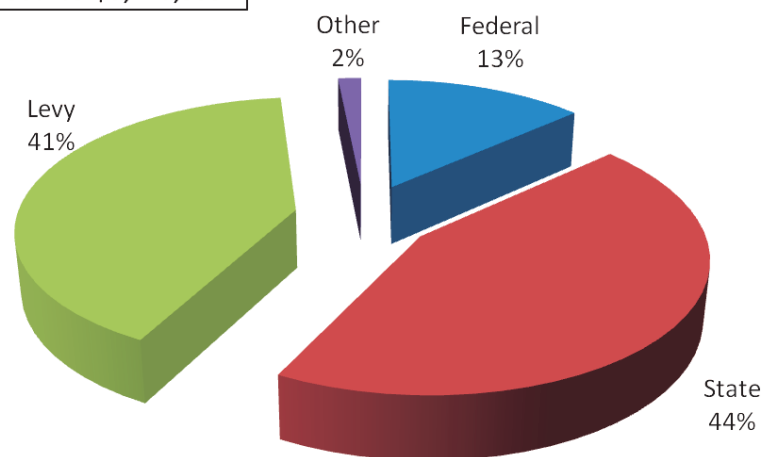


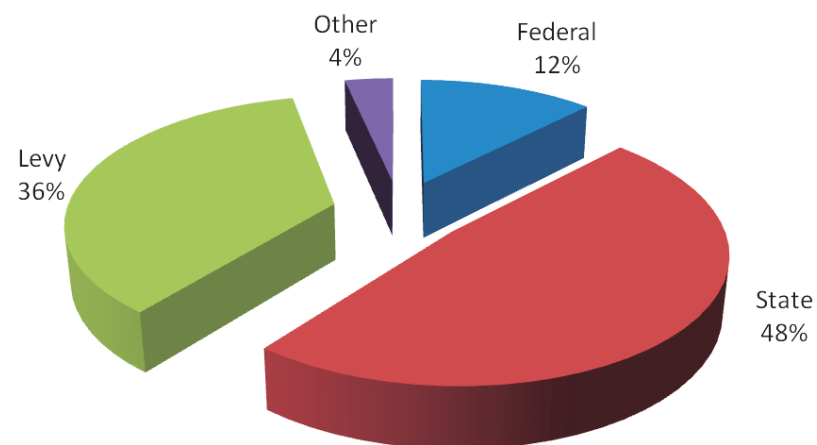
# Board finances...

## A Message from the Director Breaking Down Barriers!

*Joe Trolan, Executive Director of the Mental Health and Recovery Services Board said the Board faced many new obstacles in FY15, staff came out swinging and what originally appeared to be challenges suddenly became viewed as opportunities.*

The Board started State Fiscal Year 2015 (SFY15) with a full implementation of the GOSH IT System (GOSH). This was an internal procedure that would be viewed as seamless to the community. Through GOSH we are seeing significant data and billing efficiencies at both the Board and Agency levels. GOSH has also given the Board an opportunity to offer contract services to other counties and produce a new revenue stream.

SFY15 was exciting as it allowed the Board to enhance services in Richland County. The enhancements included diagnostic assessments at no out of pocket expense to Richland County residents. The most frequent request for help from the community prior to SFY15, was to cover out-of-pocket costs associated with initial assessment. Calls from people having problems accessing an initial assessment have virtually disappeared and we have seen an increase in access to the initial assessments of over 30%. Our agencies are also seeing a higher rate of service retention.

To help address the opiate epidemic in our county we have strengthened relationships by implementing services at the jail to coordinate initial contacts between our agencies and people leaving the jail, with the belief that they follow through with treatment upon discharge. We also have continued to partner with Third Street Family Health Services which has allowed us to provide Medication Assisted Treatment more consistently throughout the community.

## Exploring Changes in the DSM5

Cheri Walter, MA, LICDC and Chief Executive Officer of Ohio Association of County Behavioral Health Authorities provided the keynote address. Walter presented on the state-wide Initiative of Recovery is Beautiful. There were 15 breakout sessions with nearly 150 attendees.

# Richland County Becoming TIROCC

The Board envisioned Richland County becoming a Trauma Informed Recovery Oriented Community of Care.

The Richland County Board is one of 8 ROSC (Recovery-Oriented System of Care) pilot boards in Ohio. ROSC is a way of thinking about service delivery for those with mental illness and/or addiction disorders that focus first and foremost on clients and family members. ROSC emphasizes the importance of peer supports, employment supports, housing, and transportation. It calls for services that are culturally appropriate, and delivered in an accountable, effective, and efficient manner. ROSC recognizes that local management of behavioral health services are vital

and that local communities are in the best position to design and manage their Recovery-Oriented System of Care. The objective is to “Change the Conversation”. Mental illnesses and addiction disorders are chronic illnesses and can be successfully treated.

Being Trauma Informed means services are provided in a non-threatening and non-coercive manner with focus on recovery, resilience and trauma. Interdepartmental relationships are available for the exchange of information and access to cross-system services for the betterment of consumers and families. In addition is the idea that we need to care for those that are caring for individuals who are receiving services in the behavioral health system.

Richland County is working to marry these two methodologies. The belief is a trauma informed recovery oriented system will create an environment that is conducive to effective service delivery.



# A Legacy of Hope and Success!

On November 3, 2015 Richland County voters will go to the poles to vote on a 10 year 1 mil renewal levy for mental health and substance abuse treatment services.

Over seven thousand Richland County residents receive treatment through our funded agencies annually. In addition, more than three thousand Richland County youth and family members receive educational, preventive and coordination services in schools, churches and other community settings.

Levy funds help provide services through our six contract agencies: Catalyst Life Services, Community Action for Capable Youth, Family Life Counseling and Psychiatric Services, Mansfield UMADAOP, National Alliance on Mental Illness and Three C Counseling as well as several affiliate agencies and local partners.

For nearly 30 years Richland County has supported services for individuals, family members, friends and neighbors suffering from mental illness and addiction. In return, we assure that services are available to ALL Richland County Residents. We also make sure that local dollars stay local. Levy dollars pay for Richland County residents, receiving services from Richland County agencies. Our levy effort is to assure that this **Legacy of Hope and Success** will be here to provide much needed assistance to the people of Richland County now and in the future.
