Leaving a fund balance for the month of January of 4, \$722,029.20. This is a decrease of (\$291,623.51).

4. * TIROCC Steering Committee Update – Kym Lamb & Joe Trolian

Lamb said we made a survey for feedback for all of our agencies working for re-certification process. Trolian making sure agencies haven't lost ground and keeping up with the trauma informed side. Some modifications to cover all organizations. We will be sending out survey to all Board members, be watching for it in your emails. Also, the staff will be filling out a survey. Trolian requested a vote to change TIROC to TIRROC. Trauma Informed Resilience Recovery Orientated Community of Care. This would accommodate an additional focus on building resilience along with being trauma informed and recovery oriented. Lamb asked if there was a motion to approve the new TIRROC name change. In April we have an event for "Mental Health and the Church". Open for all but would like individual churches to get involved. Pastors are used as an urgent MH care crisis person allot of times. Bemiller said Malabar school has a "Care Connect" in school. And HOSPICE was suggested also. Some discussion was had.

6. Executive Director's Report – Joe Trolian

Trolian announced that Tommy Hill had to resign. Conflict of interest with Sherry's new position on Ontario City Counsel. We will be looking into another law officer to take his place. Some discussion was had, and Congratulations to Sherry Branham on her new endeavor. Community presentations have been given this past year to schools and employees, Sperion etc.... Trolian said that only 9 suicides took place 2019 compared to 23 in 2018. Trolian said we are focused much more on people being a community. Lowest suicide rate in 16 years. They are looking into deaths from overdoses to be sure they are not suicides. Branham thinks opiate response team is a big impact and our one pager per our guest Mary Kay, from NAMI. Many things are in place, so we can try to interact sooner for people in need. Our March Board meeting will be held at UMADAOP on Trimble Road. We will have Matthew Barnhart at the meeting, addressing the Board and apologizing to all for causing the fire damage at Wood Pointe three years ago.
