Cindy Lewis called the Teleconference meeting to order at 5:33 P.M.

## 1. \* Approval of June 16, 2020 meeting minutes – Cindy Lewis

#### 3. Cash Position – Sherry Branham

The cash position beginning balance as of May 31, 2020 was \$5,405,363.24. We added a total revenue of \$235,964.81. Total expenditures for the same period were \$738,610.72. Leaving a fund balance on June 30<sup>th</sup>, 2020 of 4,902,717.33. This is a decrease of \$502,645.91.

#### 4. SFY 20& 21 Executive Committees-Kym Lamb and Cindy Lewis

Lamb stated that on July 9<sup>th</sup> we held a teleconference with the combined SFY 20 and SFY 21 Executive Committees. The purpose of the meeting was to further discuss the declaration on racism that was presented during the previous meeting. Lamb referred Board members to the copy of the minutes in their Board Meeting packet. The result of the meeting was the version of the Declaration also found in the Board packet.

Lamb stated that on behalf of the combined SFY 20 and SFY 21 Executive Committees, she would like to make a motion to adopt the Declaration on Racism and Discrimination as a Public

Crisis. Mitchell seconded the motion. There was no further discussion. A roll call vote was taken with twelve approvals. The motion carried.

#### 5. SFY20 Personnel Committee-Cindy Lewis

A. Executive Director's Evaluation

Lewis asked that the minutes reflect that Executive Director Joe Trolian has satisfactorily executed his duties as Executive Director of the Richland County Mental Health and Recovery Services Board for State Fiscal year 2020 and has earned the 1% contract adjustment. No additional compensation was given due to the current fiscal state and the potential challenges that may be faced soon as a result of COVID-19.

#### 6. **Presidents Report** – Cindy Lewis

Lewis took a few minutes to thank everyone for the opportunity to serve as chair for SFY 2021. She described a Trauma and Resilience Training that she attended recently and related how this truly supports the work of what the Board, through its contract and affiliate agencies, is trying to accomplish with not only acknowledging and addressing the traumas that individuals have experienced, but also building resilience to provide individuals with tools to face future traumas with greater tenacity.

#### 7. Executive Director's Report – Joe Trolian

Trolian thanked the Board for another great year. Trolian updated the Board on the K-12 Prevention Program. They will be training 5-6 teams on August 10<sup>th</sup> and 11<sup>th</sup> on School Crisis and how to be a Critical Incident Debriefing Team for the school districts. These teams will work with their assigned schools to assist in addressing the changes and stress that will be encountered through this less than optimal upcoming school year. Mansfield, Madison, Plymouth-Shiloh, Shelby, Pioneer, Crestview, Clearfork, and the Foundation Academy have agreed to participate. Other schools that have chosen not to participate in this program were assured that any programs they currently have established at their schools through Board funding will continue regardless of their participation.

Trolian reminded Board Members that the Board does not meet in August so our next meeting will be in September.
